- Section 1: Authority: Title. This local law is enacted pursuant to the authority of Article Nine-A of the General Municipal Law of the State of New York, and shall be known as the Games of Chance Law of the Town of Clifton.
- Section 2: Definitions. The words and terms used in this local law shall have the same meaning as such words and terms are used in Article Nine-A of the General Municipal Law, unless otherwise provided herein or the context requires a different meaning; "Town" means the Town of Clifton, "Officer" means the Chief Law Enforcement Officer of St. Lawrence County.
- Section 3: Games of chance authorized; Restrictions. Games of chance may be conducted in the town by an authorized organization, after obtaining a license therefor, in accordance with the provisions, requirements and limitations of Article Nine-A of the General Municipal Law, the rules and regulations of the New York State Racing and Wagering Board and this local law.
- Section 4: Effective Date: This local law shall take effect on January 1, 1990 after approval thereof of the majority of the voters of the Town voting thereon at the general election and after publishing and posting as required by law.

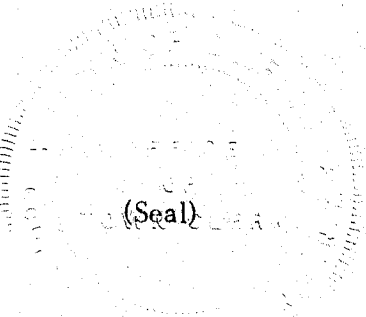
