Section 1. In accordance with the provisions of Section 458 of the Real Property Tax Law, upon the 2002 re-evaluation of all of the lands in the Village of Hermon which will result in a material change in the level of assessment, all veterans who had an exemption pursuant to eligible funds exemption on the 2001 tax roll, shall have their exemption increased by multiplying the amount of such exemption by such change in level of assessment.

Section 2. This Local Law shall take effect upon its filing with the Office of the Secretary of State of the State of New York or five (5) days after its enactment pursuant to the provisions of the Municipal Home Rule Law and shall apply for the 2002 tax year and thereafter.


